## 4. FIRST AID MEASURES

## 5. FIRE FIGHTING MEASURES

**Suitable Extinguishing Media:**

Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

**Specific hazards arising from the substance or mixture:**

Not combustible, however following evaporation of the water component of the material, the residual material can burn if ignited. On burning will emit toxic fumes, including those of oxides of carbon .

**Special protective equipment and precautions for fire-fighters:**

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

## 6. ACCIDENTAL RELEASE MEASURES

**Emergency procedures/Environmental precautions:**

If contamination of sewers or waterways has occurred advise local emergency services.

**Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:**

**SMALL SPILLS:** Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

**LARGE SPILLS:** Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water. Cured material can only be removed by cutting or abrasion.

## 7. HANDLING AND STORAGE

**Precautions for safe handling:**

Keep out of reach of children. Avoid eye contact and repeated or prolonged skin contact.

**Conditions for safe storage, including any incompatibilities:**

Store in cool place and out of direct sunlight. Store away from incompatible materials described in Section 10. Protect from freezing. Keep containers closed when not in use - check regularly for leaks.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION
