### 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

Contain – prevent run off into drains and waterways. Collect and seal in properly labelled containers or drums for disposal.

**Handling:** Avoid skin and eye contact and inhalation of vapour.
